

Noxious Weeds

The term 'noxious weeds' includes non-native, invasive grasses, shrubs and trees, flowering plants and aquatic plants. The Colorado Department of Agriculture (CDA) created the Colorado Noxious Weed Act which was developed to create and enforce regulations intended to control these weeds. There are three separate lists, A, B, and C which categorize weeds by importance for control.

LIST A:

Rare noxious weeds that must be removed statewide.
